Hi Simon:

I have taken over case management as the primary caseworker for Alameda County Environmental Health (ACEH) for the subject site. However, since this case has previously been reviewed by the Underground Storage Tank Cleanup Fund (USTCF) staff through the Five-Year Review process and recommended for closure consideration, the State Water Board staff is tasked to review this case for case closure consideration in accordance with the Board's document entitled "Implementation of Low-Threat Underground Storage Tank Case Closure Policy and Additional Program". According to the Implementation Plan the State Water Board anticipates that this review will be completed no later than August 16, 2013. Upon review the Fund Manager will recommend case closure if the site meets the eight General Criteria and the three Media-Specific Criteria of the Policy.
