Dear Mr. Panaitescu and Mr. Skance:

Thank you for the recently submitted document entitled, "Groundwater Rebound Test Work Plan," dated August 6, 2010, which was prepared by Thrifty Oil Company (TOC) for the subject site. Alameda County Environmental Health (ACEH) staff has reviewed the case file including the above-mentioned report/work plan for the above-referenced site. TOC has been operating a groundwater extraction (GWE) system at the site since April 1991. TOC states that "[t]he GWE system has been effective in reducing the petroleum hydrocarbon contamination at the site." TOC recently completed a 5-day continuous high vacuum dual-phase extraction (HVDPE) event at the site. According to TOC, the event "significantly reduced petroleum hydrocarbons even further." Based on the results, TOC has initiated an additional 30-day HVDPE event at the site. Following the completion of the HVDPE event, TOC proposes to shut-down the GWE system, allow for potential contaminant rebound, and collect groundwater samples at the site sometime after October 3, 2010.

ACEH generally concurs with the proposed scope of work and requests that you address the following technical comments, perform the proposed work, and send us the technical work plan and reports described below.

TECHNICAL COMMENTS

Contaminant Source Area Characterization/Confirmation Sampling – The USTs and associated piping were removed from the site on March 23, 1998. Soil sample analytical results detected total petroleum hydrocarbons (TPH) as gasoline (g) and benzene at concentrations of 3,900 mg/kg and 19 mg/kg, respectively. Please note that the elevated

concentrations of contaminants were still present even though, at that time, the GWE system had been in operation for approximately 7 years. Although concentrations of TPH-g and benzene in groundwater appear to have decreased over time, the extent of soil contamination in the source area(s) remains undefined and verification sampling is necessary to evaluate remediation effectiveness. Please propose a scope of work to address the above-mentioned concerns and submit a work plan due by the date specified below.

2. Groundwater Contaminant Plume Characterization – Based on initial groundwater sampling data, it appears that a significant release(s) had occurred in the past. In response to the elevated concentrations of contaminants detected in groundwater, TOC began operating the GWE system at the site in 1991. However, based on groundwater monitoring well locations and groundwater flow direction and gradient, it appears that the groundwater contaminant plume is uncharacterized in the down-gradient direction. Please propose a scope of work to address the above-mentioned concerns and submit a work plan due by the date specified below. Please note that it is recommended that a series of borings are proposed and the need for permanent monitoring points be evaluated based on the data obtained.

REPORT REQUESTS

These reports are being requested pursuant to California Health and Safety Code Section 25296.10. 23 CCR Sections 2652 through 2654, and 2721 through 2728 outline the responsibilities of a responsible party in response to an unauthorized release from a petroleum UST system, and require your compliance with this request.

ELECTRONIC SUBMITTAL OF REPORTS

ACEH's Environmental Cleanup Oversight Programs (LOP and SLIC) require submission of reports in electronic form. The electronic copy replaces paper copies and is expected to be used for all public information requests, regulatory review, and compliance/enforcement activities. Instructions for submission of electronic documents to the Alameda County Environmental Cleanup Oversight Program FTP site are provided on the attached "Electronic Report Upload Instructions." Submission of reports to the Alameda County FTP site is an addition to existing requirements for electronic submittal of information to the State Water Resources Control Board (SWRCB) GeoTracker website. In September 2004, the SWRCB adopted regulations that require electronic submittal of information for all groundwater cleanup programs. For several years, responsible parties for cleanup of leaks from underground storage tanks (USTs) have been required to submit groundwater analytical data, surveyed locations of monitoring wells, and other data to the GeoTracker database over the Internet. Beginning July 1, 2005, these same reporting requirements were added to Spills, Leaks, Investigations, and Cleanup (SLIC) sites. Beginning July 1, 2005, electronic submittal of a complete copy of all reports for all sites is required in GeoTracker (in PDF format). Please visit the SWRCB website for more information on these requirements (http://www.swrcb.ca.gov/ust/electronic_submittal/report_rgmts.shtml.

PERJURY STATEMENT

All work plans, technical reports, or technical documents submitted to ACEH must be accompanied by a cover letter from the responsible party that states, at a minimum, the following: "I declare, under penalty of perjury, that the information and/or recommendations contained in the attached document or report is true and correct to the best of my knowledge." This letter must be signed by an officer or legally authorized representative of your company. Please include a cover letter satisfying these requirements with all future reports and technical documents submitted for this fuel leak case.

PROFESSIONAL CERTIFICATION & CONCLUSIONS/RECOMMENDATIONS

The California Business and Professions Code (Sections 6735, 6835, and 7835.1) requires that work plans and technical or implementation reports containing geologic or engineering evaluations and/or judgments be performed under the direction of an appropriately registered or certified professional. For your submittal to be considered a valid technical report, you are to present site specific data, data interpretations, and recommendations prepared by an appropriately licensed professional and include the professional registration stamp, signature, and statement of professional certification. Please ensure all that all technical reports submitted for this fuel leak case meet this requirement.

UNDERGROUND STORAGE TANK CLEANUP FUND

Please note that delays in investigation, later reports, or enforcement actions may result in your becoming ineligible to receive grant money from the state's Underground Storage Tank Cleanup Fund (Senate Bill 2004) to reimburse you for the cost of cleanup.

AGENCY OVERSIGHT

If it appears as though significant delays are occurring or reports are not submitted as requested, we will consider referring your case to the Regional Board or other appropriate agency, including the County District Attorney, for possible enforcement actions. California Health and Safety Code, Section 25299.76 authorizes enforcement including administrative action or monetary penalties of up to \$10,000 per day for each day of violation.

The Alameda County Environmental Cleanup Oversight Programs (LOP and SLIC) require submission of all reports in electronic form to the county's ftp site. Paper copies of reports will no longer be accepted. The electronic copy replaces the paper copy and will be used for all public information requests, regulatory review, and compliance/enforcement activities.

REQUIREMENTS

- Please do not submit reports as attachments to electronic mail.
- Entire report including cover letter must be submitted to the ftp site as a single portable document format (PDF) with no password protection.
- It is preferable that reports be converted to PDF format from their original format, (e.g., Microsoft Word) rather than scanned.
- Signature pages and perjury statements must be included and have either original or electronic signature.
- <u>Do not</u> password protect the document. Once indexed and inserted into the correct electronic case file, the
 document will be secured in compliance with the County's current security standards and a password.
 <u>Documents with password protection will not be accepted.</u>
- Each page in the PDF document should be rotated in the direction that will make it easiest to read on a computer monitor.
- Reports must be named and saved using the following naming convention:
 RO#_Report Name_Year-Month-Date (e.g., RO#5555_WorkPlan_2005-06-14)

Submission Instructions

- 1) Obtain User Name and Password:
