Thank you once again for providing Thrifty Oil Co. (Thrifty) with permission to access your property at 3315 San Pablo Avenue, Oakland, California. This letter is to inform you that on November 30, 2010, Thrifty will be at your property to install one soil boring (SB-3) (**Figure 1**). The proposed soil boring will be installed in the corner of your property closest to the intersection of Linden Street and San Pablo Avenue. During the installation of the soil boring, groundwater and soil samples will be collected and then the soil boring will be backfilled with bentonite grout to near surface and sealed to match existing surface conditions. Thrifty will make every effort to minimize disruption to retail operations at your property.

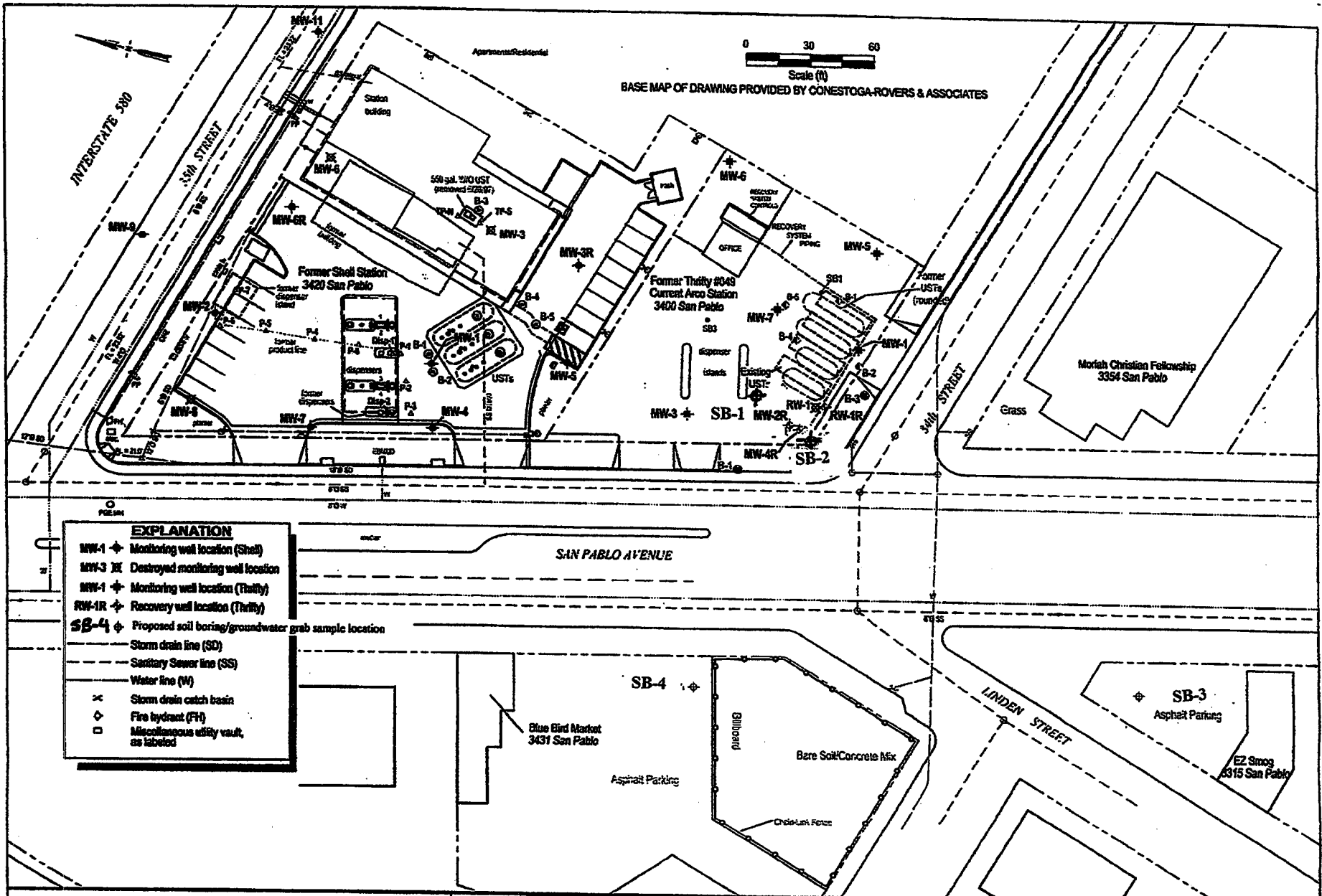
