We request that you address the following technical comments, perform the proposed work, and send us the report described below. Please provide 72-hour advance written notification to this office (e-mail preferred to: karel.detterman@acgov.org) prior to the start of field activities.

- 1. Soil Vapor Probe Reinstallation: ACEH anticipates participating in the approval process for the location of replacement vapor probes SV-13 and SV-14;
- 2. Comment numbers 2, 3, 4, 5, and 6: ACEH approves of the responses and requests including all documentation of imported fill, excavation and off-site disposal, groundwater handling and disposal, and confirmation soil sampling (referenced in comments 2 through 6) in the Interim Remediation Results Report due November 13, 2013.
- 3. Replacement monitoring well for DPE-5: we noted in our September 12, 2013 e-mail that based on field observations and analytical results, a replacement monitoring well may be required to monitor the status of free-product that was found in the vicinity of DPE-5. Please provide the rationale for or against installing a replacement monitoring well based on the findings of the interim source removal in the Interim Remediation Results Report due November 13, 2013.
