Please note that the two subject cases predate the GeoTracker database. Hence the following language is located in both GeoTracker cases:

Not all historic documents for the fuel leak case may be available on GeoTracker. A more complete historic case file for this site is located on the Alameda County Environmental Health website at <https://ehgis.acgov.org/dehpublic/dehpublic.jsp>.

Additionally, the two subject cases are linked in GeoTracker.

I'm surprised the data for the soil bores having the prefixes of SB-, BH-, and GP- were not identified by Jeff in the Port case files, which I expect are more complete than those on the ACEH ftp and GeoTracker web sites. As a result, I was anticipating more data being presented in the plume delineation report than I was aware of.

The follow are references to some of the missing soil bore data:

RO0000010 Case File:

SWI 1996-01-30: 'SB' data.

RO0000187 Case File:

SWI 1995-07-26: 'GP' data.
