Dear Ms. Roe:

ARCADIS U.S., Inc. (ARCADIS) is submitting this letter to propose additional remedial activities based on recent observations at former BP service station #11132 located at 3201 35th Avenue in Oakland, California (site). During implementation of the dual phase extraction (DPE) test described in the *Proposal for DPE* (ARCADIS, 2012), ARCADIS observed approximately 1.5 feet of separate phase hydrocarbons (SPH) in OW-1 (refer to attached site plan for well location). ARCADIS bailed the product and observed a recharge of approximately 0.4 feet the following day. ARCADIS proposes to conduct SPH bail down at all wells that potentially contain product (OW-1 and MW-10) in order to remove SPH to the extent possible and to better understand recharge rates to improve remedial effectiveness.

ARCADIS proposes to implement the first round of SPH bail down in January 2013 and will continue on a monthly basis for 3 months. If you have any questions or comments, please do not hesitate to contact me at (415) 432-6903 or by e-mail at hollis.phillips@arcadis-us.com.




