Alameda County Environmental Health (ACEH) staff has reviewed the case file including the most recent correspondence, dated November 11, 2012, the most recent directive letter, dated June 17, 2011, and most recent submitted document entitled *ACEH Low Threat Closure Policy Checklist and Site Conceptual Mode* dated June 28, 2013, prepared by ARCADIS, U.S., Inc. (ARCADIS) for the subject site. The above-referenced document states that additional investigation is required to eliminate data gaps related to down gradient concentrations of potential chemicals of concern in soil vapor and groundwater. ARCADIS stated they would submit a work plan to characterize down gradient soil vapor and groundwater. However, as of this date ACEH has not received a work plan for the proposed investigation.
