Dear Mr. Desso and Mr. Hall:

Future closure of your case is expected to leave a significant amount of residual contamination in place. In order to prevent future exposure to the residual contamination, the site management requirements that are described in the "Covenant and Environmental Restriction on Property" and "Risk Management Plan," dated February 3, 2011, must be implemented and maintained. ACEH is requesting a deposit of \$8,000 to cover future regulatory oversight costs for periodic site inspections, assuring that the site management requirements are maintained in the future, and answering inquiries from future developers, buyers, occupants, or neighbors regarding the residual contamination.

In the event that the site is to be redeveloped, approved development/construction plans are to be submitted to ACEH for review and approval. At the time of plan submittal, ACEH would request funds directly from the redeveloper to cover regulatory costs for review and approval of development/construction plans.

Please send your check(s) for \$8,000 made payable to Alameda County Environmental Health to the attention of our Finance Department. If both responsible parties are sharing the costs equally, Encinal 14th Street LLC should submit a check for \$4,000 and Nestle USA should also submit a check for \$4,000. Please write "SLIC" (the type of project), the site address, and the Account ID# AR0320138 on your check.
