Hi Paresh:

Matriks is the consultant for owners of Alaska Gas at 1310 Central Avenue.

I left a voice mail for you as well but thought I would send most of the details via email.

You spoke with Tom Henderson last week regarding Alaska Gas and their Geotracker status. You updated their information on 4/23/09 which appears to have brought them into compliance. As Tom explained, the UST Cleanup Fund rejected a reimbursement request because of the Geotracker compliance issue. It seems that at the time they rejected it, the requested information had been submitted to Alameda County and Geotracker but hadn't been ok'd by Alameda County yet. Now that you have ok'd the information, would it be possible for you to write a brief letter/note to the Fund letting them know what had happened and that the Site was in compliance, it was just the formality of signing off on the submittals that didn't happen until recently, mentioning that the information was submitted in mid 2008? The claim reviewer from the Fund said that he would be willing to accept the reimbursement request resubmittal and consider the original submittal date of 10/2008. As you are probably aware, the date of submittal for requests to the State Fund is important right now because of the money issues at the State.

The Site's claim no. is 12650 and the gentleman I have spoken to at the Fund is William Wong, his email if you'd like is wwond@waterboards.ca.gov.
