This is a notice of enforcement referral for the subject site. Site Responsible Parties have not completed work as requested by Alameda County Environmental Health (ACEH) and are recalcitrant in implementing site investigation. As a consequence, Alameda County Environmental Health (ACEH) is referring this site to the San Francisco Bay Regional Water Quality Control Board for enforcement actions.

The subject site is co-mingled with a downgradient fuel release case currently overseen by the Hayward Fire Department. Two unregistered backyard residential wells downgradient of that site are impacted with fuel hydrocarbons. The wells are reported to be actively used by their owners. The subject site is making very limited progress, and multiple deliverables are late. Additional deliverables are due in the near future.
