Alameda County Environmental Health (ACDEH) staff has reviewed your correspondence dated February 18, 2015 that objects to closure of fuel leak case RO0000026 with site management requirements. Potential increased costs for site redevelopment is cited as a future burden and liability for Thrifty as the current property owner. The February 18, 2015 correspondence indicates that the current lease at the site is scheduled to end on May 13, 2019 at which time, Thrifty may redevelop the site

The potential for site redevelopment in four years is not a sufficient basis to keep the case open or to continue investigation and site cleanup to achieve unrestricted land use. If definitive redevelopment plans proceed in 2019, the site can be re-evaluated at that time. ACDEH will proceed with the case closure process.
