Thank you for participating in the July 31, 2014 meeting with Alameda County Environmental Health (ACEH) at our office to discuss the case status. The Responsible Parties (RPs), the Cotters and the Coyle's, have decided to proceed with site remediation irrespective of site development, a modification from the ACEH-approved *Feasibility Study/Corrective Action Plan* (FS/CAP) dated October 8, 2013 prepared on your behalf by URS.
