Dear Mr. Walter:

Alameda County Department of Environmental Health (ACDEH) staff has reviewed the case file including the documents entitled *Sensitive Receptor Survey* (SRS) dated April 24, 2017 and submitted August 8, 2017, and the *Adeline Maintenance Facility Data Review* (DR), dated August 26, 2016 and submitted August 26, 2017. Both documents were prepared by Engineering/Remediation Resources Group, Inc. (ERRG) for the subject site. The SRS and DR were prepared at the request of ACDEH in our letter of June 24, 2016.

The SRS was performed as a result of recommendations in the report entitled *Technical Memo* dated June 30, 2015 and prepared by AECOM. AECOM proposed groundwater monitoring well installation in areas of concern (AOCs), designated AOC-1 and AOC-3, as the petroleum hydrocarbon contaminant plumes were undefined in these areas. ACDEH staff was of the opinion the plume delineation studies were premature as sensitive receptors in the vicinity had not been identified, resulting in our SRS request.

The DR was prepared in order to evaluate residual contaminant concentrations identified in the May 21, 2009 soil and groundwater investigation (SWI) with regard to updated San Francisco Bay Region, Regional Water Quality Control Board (Region 2) Environmental Screening Levels (ESLs). The SWI document, entitled *Site Investigation Report*, was prepared for the subject site by Alisto Engineering Group (Alisto).

ACDEH staff requests a meeting to discuss the case status and the path toward closure. ACDEH proposes a meeting time and date of **10:00 AM on Thursday, July 19, 2018** to be held at our offices.
