Notice to Comply Letter of November 18, 2010 for Fuel Leak Case No.

RO#000035 and Fuel Leak Case RO#0000435

Dear Ms. Drogos:

The Port of Oakland ("Port") is in receipt of Mr. Paresh Khatri's letter, dated 18 November 2010. I understand that Mr. Khatri has transferred to another position in the County, so I am responding to you. Mr. Khatri's letter refers to the Port's being in non-compliance with: 1) an Alameda County Environmental Health ("ACEH") October 23, 2000 letter requiring corrective action; and 2) a requirement to claim the site on the State Water Resources Control Board ("SWRCB") Geotracker site. The ACEH November 18, 2010 letter refers to two sites:

- Fuel Leak Case No RO0000035, Geotracker Global ID T0600101587, Port of Oakland/Union Pacific Railroad at 1717 Middle Harbor Road, Oakland, CA 94607; and
- Fuel Leak Case No. RO0000435, Geotracker Global ID T0600101421, Port of Oakland/Union Pacific Motor Freight at 1750 Ferro Street, Oakland, CA 94607

The Port accessed GeoTracker and found that ACEH was listed as the lead regulatory agency for the two sites identified above. One of the sites is referred to as the Trailer on Flat Car Site ("TOFC") and the other site is referred to as the Union Pacific Motor Freight site ("UPMF"). In addition, GeoTracker has a third site, listed as T0600191529, entitled "Union Pacific Motor Freight". For the third site, the San Francisco Bay Regional Water Quality Control Board ("RWQCB") is listed as the Lead Agency and ACEH as the Local Oversight Program.

Regarding Mr. Khatri's November 18, 2010, notice about corrective action implementation, it is not clear to which site he is referring. In 2000, the Port was planning to reconstruct the TOFC treatment system during the Port's Vision 2000 Maritime Development Program Construction Program for new marine terminals.

The RWQCB oversaw the TOFC system reconstruction and operation and the recent system shutdown. In addition, the Port has been working with the RWQCB to obtain closure of the TOFC site and has negotiated a proposed Deed Restriction with the RWQCB. The Port is also completing a Site Management Plan covering the TOFC site for submittal to and approval by the RWQCB.

Mr. Khatri's concerns regarding GeoTracker compliance is unclear. On 13 August 2009, the Port claimed the GeoTracker site Fuel Leak Case No. RO0000435 following receipt of a prior Notice of Violation, dated July 28, 2009 (pertaining to the UPMF site) (see attached Accepted Document on FTP Site). In addition, the GeoTracker user name and password set up in August 2009 remain active for the UPMF site.

The Port respectfully requests a meeting with you and/or your staff to resolve to which site the November 18, 2010, letter refers and to determine the actions the Port needs to take to ensure compliance with ACEH requirements. The Port is available for a meeting at your convenience. The attendees from the Port would be Mr. John Prall and Ms. Yane Nordhav of BASELINE Environmental Consulting. Since the November 18, 2010 letter requests that the Port claim the Geotracker "site" by December 20, 2010, the Port would appreciate an opportunity to meet with you and/or your staff before that date. If a meeting is not possible before December 20, 2010, we would request a time extension for complying with the requirements of the November 18, 2010, letter until after our proposed meeting.
