The Alameda County Department of Environmental Health (ACDEH) Local Oversight Program (LOP) is identified in State Water Resources Control Board's (SWRCBs) GeoTracker database as the lead agency for the subject fuel leak cases. Following communications with the staff of both the Port of Oakland and the San Francisco Bay Region Regional Water Quality Control Board (SFBR-RWQCB) through March of 2015, a determination was made that these cases are in under the jurisdiction of the SFBR-RWQCB based on your Order 99-055 and the Port of Oakland's Vision 2000 (V2K) program.

As expressed in our phone conversations and requested in our letter to your agency dated June 9, 2016, ACDEH wishes to perform an administrative closure for the above referenced cases, and identify the SFBR-RWQCB as the lead agency. In order to achieve this, ACDEH requests a letter from your agency, on SFBR-RWQCB letterhead, to be placed in the subject case files indicating these cases are in your Port of Oakland portfolio and that the SFBR-RWQCB is the acknowledged lead agency. Please provide the letter to ACDEH either by an electronic mail attachment or via land mail by **June 15, 2018**.
