Dear Mr. and Ms. Macias and Mr. Moody:

A review of the case file for the above-referenced site indicates that your case is currently not in compliance with Alameda County Environmental Health's (ACEH) March 24, 2010 correspondence, which required submittal of the List of Landowners Form (by April 23, 2010) and monitoring well destruction for case closure in accordance with California Well Standards (by June 22, 2010). To date, the List of Landowners Form has not been received and the monitoring wells have not been decommissioned. In addition, your site has not been claimed in the State Water Resources Control Board's GeoTracker website, as required.

In order to regain compliance and receive case closure, please submit the List of Landowners Form, decommission the monitoring wells, claim your site in GeoTracker, and submit a summary report by the date specified below. Failure to decommission the wells submit the required documents by the due dates specified below may result in an issuance of a Notice of Violation and possible enforcement action and possible penalties by the District Attorney and/or ineligibility for reimbursement of corrective action costs incurred at the site from the Underground Storage Tank Clean-up Fund. Furthermore, ACEH will recommend removal of this site from the Underground Storage Tank Cleanup Fund. Pursuant to Chapter 6.7, California Health and Safety code, civil penalties up to \$10,000 for each UST for each day of violation may be imposed. Once removed from the Cleanup Fund, the costs associated with the monitoring well destruction work that is required will not be reimbursed. Please note that civil penalties for non-compliance are assessed from the original due date (June 22, 2010).

Dear Mr. and Ms. Macias and Mr. Moody:

Alameda County Environmental Health (ACEH) and California Regional Water Quality Control Board staff have reviewed the fuel leak case file and case closure summary for the abovereferenced site and concur that no further action related to the underground storage tank fuel release is required at this time. Prior to issuance of a remedial action completion certificate, the monitoring well installed at the site is to be properly destroyed, per California Water Code and all current record owners of fee title to the site must be notified of the proposed case closure action by the primary or active responsible party.

We request that you address the following technical comments, perform the proposed work, and send us the technical reports and documents requested below.

TECHNICAL COMMENTS

- Monitoring Well Decommissioning for Case Closure ACEH is requesting that you contact Alameda County Public Works Agency at (510) 567-6791, obtain the necessary permits, destroy the well(s), and electronically upload the monitoring well decommissioning report to ACEH's FTP server and the State Water Resources Control Board's GeoTracker website within ninety (90) days from the date of this letter (June 22, 2010). Electronic reporting is described in detail below. Upon our receipt of the report of well destruction, List of Landowners Form and confirmation of investigation derived waste disposal, this office will issue you the remedial action completion certificate.
- 2. Landowner Notification As you may be aware, an investigation resulting from underground storage tank leaks was performed at the subject property to which you are named as the primary or active responsible party. Pursuant to Section 25297.15 (a), Alameda County Environmental Health (ACEH), the local agency, shall not consider cleanup or site closure proposals from the primary or active responsible party, issue a closure letter, or make a determination that no further action is required with respect to a site upon which there was an unauthorized release of hazardous substances from an underground storage tank subject to this chapter unless all current record owners of fee title to the site of the proposed action have been notified of the proposed action by the primary or active responsible party. ACEH is required to notify the primary or active responsible party of their

requirement to certify in writing to the local agency that the notification requirement in the above-mentioned regulation has been satisfied and to provide the local agency with a complete mailing list of all record fee title owners.

Also your comments, if any, must be considered prior to the proposed cleanup or closure. Please respond within 30 days from the date of this letter for your comments to be considered.
