With this letter Fugro West Inc. (Fugro) documents the completion of well destruction activities at the subject Site. Well destruction activities were completed in general accordance with our Work Plan dated November 12, 2008. Well destruction was completed to address the Alameda County Health Care Services Agency, Environmental Protection (County) letter dated July 15, 2008 that indicted final approval of case closure conditioned upon destruction of the existing monitoring wells.

Fugro's Work Plan indicted that well destruction would comprise pressure-grouting each well and removing the upper 5 feet of casing. Based on discussions with the Alameda County Public Works Agency (PWA), Fugro was instructed to overdrill the full length of each well, if practical. Based upon the difficult overdrilling and traffic control conditions encountered at the first well (MW-6), PWA agreed to allow pressure grouting at the remaining locations as described below.

On June 16th though 18th, 2009, Fugro completed the well destruction activities with oversight and in coordination with PWA. Fugro contracted with RSI Drilling, a licensed drilling contractor (C-57# 802334), to destroy groundwater monitoring wells MW-2, MW-3, MW-6, MW-8, MW-19, MW-22 and MW-23. Note that Fugro checked the project area on several occasions but was unable to locate wells MW-7, MW-17 and MW-18. Well destruction activities consisted of the following:

- Procured drilling PWA Permits #W2008-0881 through W2008-0887 (Attached).
- Procured required encroachment, obstruction, and traffic control permits from the City of Oakland (Attached).





- Conducted field reconnaissance to locate and assess conditions of existing wells. We were unable to located Wells MW-7, MW-17 and MW-18, which presumably were removed during various street and sidewalk improvements since well installation.
- Coordinated traffic control and access to wellhead locations to facilitate well destruction.
- Overdrilled Well MW-6 using a truck-mounted hollow stem auger rig. Grouted the resulting boring using neat cement grout tremied from 43 feet below ground surface to the 0.5 feet below ground surface. No groundwater surfaced during tremie grouting activities.
- Injected neat cement grout into wells; MW-2, MW-3, MW-8, MW-19, MW-22, and MW-23, under a pressure of at least 15 PSI. During well injection, was conducted on June 17, 2009. Fugro noted that typical grout volumes exceeded the calculated well casing volume by 50 to 100 percent. No groundwater surfaced during pressure grouting activities.
- For Wells MW-2, MW-3, MW-8, MW-19, MW-22, and MW-23, removed the well box and upper 2 to 3 feet of casing by hand, and capped former wellheads with rapid set concrete. Well box removal and capping was conducted on June 18, 2009. Fugro noted that the cement grout had not settled significantly from the prior day of grout injection.
- Investigation derived waste comprised well boxes, PVC well casing, and a minor amount of concrete.
- The soil cuttings from MW-6 were placed in labeled, DOT-approved 55-gallon drums and transported to NRC for proper disposal as non-hazardous waste.
- Well abandonment forms (DWR-188) will be submitted to the proper State and County agencies under separate cover.

With the completion of these well destruction activities, Fugro has completed the well destruction activities required by County. On behalf of the City of Oakland, Fugro respectfully requests that the County provide written confirmation that no further action is required for this case.










VICINITY MAP

Specific Work Permit Conditions

- 1. Drilling Permit(s) can be voided/ cancelled only in writing. It is the applicant's responsibility to notify Alameda County Public Works Agency, Water Resources Section in writing for an extension or to cancel the drilling permit application. No drilling permit application(s) shall be extended beyond ninety (90) days from the original start date. Applicants may not cancel a drilling permit application after the completion date of the permit issued has passed.
- 2. Prior to any drilling activities, it shall be the applicant's responsibility to contact and coordinate an Underground Service Alert (USA), obtain encroachment permit(s), excavation permit(s) or any other permits or agreements required for that Federal, State, County or City, and follow all City or County Ordinances. No work shall begin until all the permits and requirements have been approved or obtained. It shall also be the applicants responsibilities to provide to the Cities or to Alameda County an Traffic Safety Plan for any lane closures or detours planned. No work shall begin until all the

permits and requirements have been approved or obtained.

- 3. Compliance with the well-sealing specifications shall not exempt the well-sealing contractor from complying with appropriate State reporting-requirements related to well construction or destruction (Sections 13750 through 13755 (Division 7, Chapter 10, Article 3) of the California Water Code). Contractor must complete State DWR Form 188 and mail original to the Alameda County Public Works Agency, Water Resources Section, within 60 days. Including permit number and site map.
- 4. Applicant shall submit the copies of the approved encroachment permit to this office within 60 days.
- 5. Applicant shall contact Vicky Hamlin for an inspection time at 510-670-5443 or email to vickyh@acpwa.org at least five (5) working days prior to starting, once the permit has been approved. Confirm the scheduled date(s) at least 24 hours prior to drilling.
- 6. Permitte, permittee's contractors, consultants or agents shall be responsible to assure that all material or waters generated during drilling, boring destruction, and/or other activities associated with this Permit will be safely handled, properly managed, and disposed of according to all applicable federal, state, and local statutes regulating such. In no case shall these materials and/or waters be allowed to enter, or potentially enter, on or off-site storm sewers, dry wells, or waterways or be allowed to move off the property where work is being completed.
- 7. Remove the Christy box or similar structure. Destroy well by overdrilling & Tremie Grouting with Cement. After the seal has set, backfill the remaining hole with concrete or compacted material to match existing.
- 8. Remove the Christy box or similar structure.

Destroy well by grouting neat cement with a tremie pipe or pressure grouting (25 psi for 5min.) to the bottom of the well and by filling with neat cement to three (3-5) feet below surface grade. Allow the sealing material to spill over the top of the casing to fill any annular space between casing and soil.

After the seal has set, backfill the remaining hole with concrete or compacted material to match existing conditions.

- 9. Copy of approved drilling permit must be on site at all times. Failure to present or show proof of the approved permit application on site shall result in a fine of \$500.00.
- 10. All wells located on City streets shall be drilled out and follow condition #7.

All wells not located on City streets can be destroyed following condition #8.


