Dear Messrs. Gillis and Glasper:

Alameda County Environmental Health (ACEH) staff has reviewed the case file for the above-referenced site including the recently submitted document entitled, "Groundwater Monitoring Well Installation Report," dated August 4, 2009, which was prepared by AllWest Environmental, Inc. (AllWest) for the subject site. Soil sample analytical results during the recent monitoring well installations detected total petroleum hydrocarbons (TPH) as diesel (d) and motor oil (mo) at 6,700 mg/kg and 2,100 mg/kg, respectively, in soil sample MW-1-12.0 collected from MW-1. Groundwater sample analytical results detected TPH-d at a concentration of 390 micrograms per liter (µg/L) in a groundwater sample collected from MW-1 located near the former dispenser island. AllWest states that the site meets the definition of a "Low Risk" case as described in the San Francisco Bay Regional Water Quality Control Board's (RWQCB) January 5, 1996 Memorandum termed "Supplemental Instructions to State Water Board December 8, 1995 Interim Guidance on Required Cleanup at Low-Risk Fuel Sites," and subsequently recommends case closure.

Based on a review of the above-mentioned report, case closure for the subject site has not been justified and at this time, the site does not appear to meet the six criteria listed in the RWQCB's guidance document as detailed in the technical comments below. ACEH requests that you address the following technical comments, perform the proposed work, and send us the technical reports requested below.

TECHNICAL COMMENTS

Secondary Source Area / "Free Product" – Significantly elevated concentrations of TPH-d have been detected in soil samples 75191-S, SB-2, and SB-7, collected on July 14, 2008 and located near the dispenser island. Specifically, concentrations of TPH-d up to 12,000 mg/kg were detected in soil sample 75191-S, located in the southern portion of the dispenser island indicating that significant residual source exists at the site. "Grab" groundwater sample analytical results collected from soil boring SB-7 detected TPH-d and TPH-mo as high as

 $380,000~\mu g/L$ and $130,000~\mu g/L$, respectively, indicating that the residual source appears to be adversely impacting groundwater at the site. Although a groundwater sample collected from monitoring well MW-1 detected TPH-d at a concentration of $390~\mu g/L$, the laboratory noted that "lighter than water immiscible sheen/product is present" in the sample. Therefore, it does not appear that "ongoing sources, including free product, have been removed or remediated." To that end, active remediation appears necessary to mitigate elevated concentrations of hydrocarbons present in soil and groundwater. Preparation of a Feasibility Study/Corrective Action Plan (FS/CAP) appears warranted.

2. Feasibility Study/Corrective Action Plan - Since the contaminant source areas appear adequately characterized, a Feasibility Study/Corrective Action Plan (FS/CAP) prepared in accordance with Title 23, California Code of Regulations, Section 2725 appears appropriate. The FS/CAP must include a concise background of soil and groundwater investigations performed in connection with this case and an assessment of the residual impacts of the chemicals of concern (COCs) for the site and the surrounding area where the unauthorized release has migrated or may migrate, which have been well summarized in the reports submitted to date. The FS/CAP should also include, but not limited to, a detailed description of site lithology, including soil permeability, and most importantly, contamination cleanup levels and cleanup goals, in accordance with the San Francisco Regional Water Quality Control Board (SFRWQCB) Basin Plan and appropriate ESL guidance for all COCs and for the appropriate groundwater designation. Please note that soil cleanup levels should ultimately (within a reasonable timeframe) achieve water quality objectives (cleanup goals) for groundwater in accordance with the SFRWQCB Basin Plan. Please specify appropriate cleanup levels and cleanup goals in accordance with 23 CCR Section 2725, 2726, and 2727 in the FS/CAP.

The FS/CAP must evaluate at least three viable alternatives for remedying or mitigating the actual or potential adverse effects of the unauthorized release(s) besides the "no action" and "monitored natural attenuation" remedial alternatives. Each alternative shall be evaluated not only for cost-effectiveness but also its timeframe to reach cleanup levels and cleanup goals, and ultimately the Responsible Party must propose the most cost-effective corrective action. Please submit the FS/CAP due by the date specified below.

3. Groundwater Contaminant Plume Monitoring – Only one round of groundwater sampling has been conducted since the groundwater monitoring wells were installed in June 2009. In order to evaluate groundwater contaminant plume stability, consecutive groundwater monitoring of the newly installed groundwater monitoring well must be conducted. Please initiate quarterly groundwater monitoring at the site for an additional three quarters. Your consultant may propose and justify an alternate groundwater monitoring plan for review. This may be incorporate this into the above requested FS/CAP.

NOTIFICATION OF FIELDWORK ACTIVITIES

Please schedule and complete the fieldwork activities by the date specified below and provide ACEH with at least three (3) business days notification prior to conducting the fieldwork.

TECHNICAL REPORT REQUEST

Please submit technical reports to ACEH (Attention: Paresh Khatri), according to the following schedule:

- **November 16, 2009** Feasibility Study/Corrective Action Plan
- **Due within 30 Days of Sampling** Quarterly Monitoring Report (3rd Quarter 2009)
- **Due within 30 Days of Sampling** Quarterly Monitoring Report (4th Quarter 2009)
- **Due within 30 Days of Sampling** Quarterly Monitoring Report (1st Quarter 2010)

These reports are being requested pursuant to California Health and Safety Code Section 25296.10. 23 CCR Sections 2652 through 2654, and 2721 through 2728 outline the responsibilities of a responsible party in response to an unauthorized release from a petroleum UST system, and require your compliance with this request.

ELECTRONIC SUBMITTAL OF REPORTS

ACEH's Environmental Cleanup Oversight Programs (LOP and SLIC) require submission of reports in electronic form. The electronic copy replaces paper copies and is expected to be used for all public information requests, regulatory review, and compliance/enforcement activities. Instructions for submission of electronic documents to the Alameda County Environmental Cleanup Oversight Program FTP site are provided on the attached "Electronic Report Upload Instructions." Submission of reports to the Alameda County FTP site is an addition to existing requirements for electronic submittal of information to the State Water Resources Control Board (SWRCB) GeoTracker website. In September 2004, the SWRCB adopted regulations that require electronic submittal of information for all groundwater cleanup programs. For several years, responsible parties for cleanup of leaks from underground storage tanks (USTs) have been required to submit groundwater analytical data, surveyed locations of monitoring wells, and other data to the GeoTracker database over the Internet. Beginning July 1, 2005, these same reporting requirements were added to Spills, Leaks, Investigations, and Cleanup (SLIC) sites. Beginning July 1, 2005, electronic submittal of a complete copy of all reports for all sites is required in GeoTracker (in PDF format). Please visit the SWRCB website for more information on these requirements (http://www.swrcb.ca.gov/ust/electronic_submittal/report_rgmts.shtml.

PERJURY STATEMENT

All work plans, technical reports, or technical documents submitted to ACEH must be accompanied by a cover letter from the responsible party that states, at a minimum, the following: "I declare, under penalty of perjury, that the information and/or recommendations contained in the attached document or report is true and correct to the best of my knowledge." This letter must be signed by an officer or legally authorized representative of your company. Please include a cover letter satisfying these requirements with all future reports and technical documents submitted for this fuel leak case.

PROFESSIONAL CERTIFICATION & CONCLUSIONS/RECOMMENDATIONS

The California Business and Professions Code (Sections 6735, 6835, and 7835.1) requires that work plans and technical or implementation reports containing geologic or engineering evaluations and/or judgments be performed under the direction of an appropriately registered or certified professional. For your submittal to be considered a valid technical report, you are to present site specific data, data interpretations, and recommendations prepared by an appropriately licensed professional and include the professional registration stamp, signature, and statement of professional certification. Please ensure all that all technical reports submitted for this fuel leak case meet this requirement.

UNDERGROUND STORAGE TANK CLEANUP FUND

Please note that delays in investigation, later reports, or enforcement actions may result in your becoming ineligible to receive grant money from the state's Underground Storage Tank Cleanup Fund (Senate Bill 2004) to reimburse you for the cost of cleanup.

AGENCY OVERSIGHT

If it appears as though significant delays are occurring or reports are not submitted as requested, we will consider referring your case to the Regional Board or other appropriate agency, including the County District Attorney, for possible enforcement actions. California Health and Safety Code, Section 25299.76 authorizes enforcement including administrative action or monetary penalties of up to \$10,000 per day for each day of violation.

The Alameda County Environmental Cleanup Oversight Programs (LOP and SLIC) require submission of all reports in electronic form to the county's ftp site. Paper copies of reports will no longer be accepted. The electronic copy replaces the paper copy and will be used for all public information requests, regulatory review, and compliance/enforcement activities.

REQUIREMENTS

- Entire report including cover letter must be submitted to the ftp site as a single portable document format (PDF)
 with no password protection. (Please do not submit reports as attachments to electronic mail.)
- It is **preferable** that reports be converted to PDF format from their original format, (e.g., Microsoft Word) rather than scanned.
- Signature pages and perjury statements must be included and have either original or electronic signature.
- Do not password protect the document. Once indexed and inserted into the correct electronic case file, the
 document will be secured in compliance with the County's current security standards and a password.
 Documents with password protection will not be accepted.
- Each page in the PDF document should be rotated in the direction that will make it easiest to read on a computer monitor.
- Reports must be named and saved using the following naming convention:

RO#_Report Name_Year-Month-Date (e.g., RO#5555_WorkPlan_2005-06-14)

Additional Recommendations

A separate copy of the tables in the document should be submitted by e-mail to your Caseworker in Excel format.
 These are for use by assigned Caseworker only.

Submission Instructions

- 1) Obtain User Name and Password:
