

- 1. Prepared and submitted the First Quarter 2009 Status Report (BAI, 4/30/2009).
- 2. Prepared and submitted revised site figure for work plan as requested by ACEH in their work plan approval letter dated 16 April 2009.
- 3. Implemented *Work Plan for On-Site Soil Investigation* (BAI, 12/12/2008). Work conducted by Stratus Environmental Inc. (Stratus) on 10 June 2009.

WORK PROPOSED FOR NEXT QUARTER (Third Quarter 2009):

- 1. Prepared and submitted this Second Quarter 2009 Status Report (contained herein).
- 2. Prepare and submit On-Site Soil Investigation Report to ACEH following receipt and analysis of certified field data package from Stratus.

DISCUSSION:

A Work Plan for On-Site Soil Investigation (BAI, 12/12/2008) for residual soil contamination characterization was submitted to ACEH as requested in their directive letter dated 16 October 2008 to Atlantic Richfield Company. In their response letter dated 16 April 2009, ACEH generally approved the submitted work plan with technical comments, including a request to submit a revised site figure by 30 April 2009. Receiving no response from ACEH within 30 days, BAI authorized Stratus to implement the work plan using the revised site figure. Following preliminary activities, Stratus implemented the on-site soil investigation on 10 June 2009. BAI is currently awaiting receipt of the certified field data package from Stratus. A request will be submitted to ACEH to extend the current due date from 15 July 2009 for the resulting report. A copy of the Revised Site Map with Proposed Soil Boring Locations and Excavation Limits is provided as an attachment.
