I wanted to update you on additional construction delays associated with this project. Excavation did not get under way until early November and the work has been progressing slowly, primarily due to a lower number of trucks available for off-haul than was expected, difficulties with tie-back drilling related to shoring, and the rain events at Thanksgiving. The shoring issues just wrapped up this week and the excavation contractor is rolling again, as long as the current storms don't impede things. The GC is currently expecting to finish excavation near the end of January. With four weeks for report preparation and obtaining disposal documentation, I expect the report to be ready around March 1. As we move through January and understand the rate of progress, I will update you again.

I am writing to let you know there have been various schedule delays with getting this project rolling. The demolition portion was just completed in July and the contractors are getting set to begin soldier pile installation for shoring. This will be followed by installation and plumbing of the dewatering wells, which will likely pump for about 4 weeks prior to the start of excavation. The latest version of the project schedule indicates that soil excavation will be completed by early to mid-November. It will take approximately 4 weeks for PES to gather the disposal documentation and prepare the completion report. My hope is to have the report to you before the end of the year. I will keep you posted as the construction progresses and try to forecast further adjustments to the schedule.
