Dear Ms. Heinze,

Thank you and Port of Oakland (Port) representatives Richard Sinkoff, John Prall, Jeff Jones, Douglas Herman, and Colleen Liang for the opportunity for Alameda County Environmental Health (ACEH) to review with you the status of the cases in ACEH's Port case portfolio in the meeting held at the Port offices on June 18, 2014. Amongst the items discussed at the meeting, the Port and ACEH agreed that the Port will provide ACEH a summary report resolving the Berth 30 cases consisting of RO59 (Port of Oakland / Albers Mill / Berth 30), RO101 (Port of Oakland / Kaiser & Powerine Oil / Berth 30), and RO2766 (Port of Oakland, 4444 Berth 30).

As discussed, a summary report will be prepared addressing whether to combine the two cases in the Local Oversight Program (LOP), cases RO59 and RO101, with case RO2766 in the Site Cleanup Program (SCP). The report will include a table identifying all documents in each file on the ACEH ftp and Geotracker websites for RO59 and RO101 and verification that these files belong to these cases. As agreed, due to the age of the reports and Port staff concerns regarding the accompanying perjury statements, the Port will provided these documents on a CD for upload by our staff.

A second report addressing RO2766 will include a table identifying all documents in each file on the ACEH ftp and Geotracker websites for RO2766 and verification that these files belong to this case. The table will also include references to relevant documents in the possession of the Port not on the ACEH ftp and Geotracker websites for the case. As agreed, due to the age of the reports and Port staff concerns regarding the accompanying perjury statements, the Port will provided these documents on a CD for upload by our staff.

Please upload the technical reports to the ACEH ftp site (Attention: Keith Nowell), and to the State Water Resources Control Board's Geotracker website, in accordance with the following specified file naming convention and schedule:

- **August 17, 2014– Summary Report** (file name: RO0000059-101_CASE_SUM_R_YYYY-MM-DD)
- **September 1, 2014– Summary Report** (file name: RO000002766_CASE_SUM_R_YYYY-MM-DD)
