Thanks for the status update just now, and thanks for clarifying the placement of the wells. Please use this email to document ACEH concurrence with the placement of the three wells as proposed. I do note that the number has increased from two. I think that is wise given the concentrations and the locations of those concentrations as documented in the soil bore program recently completed; it should help move the project further along the path it needs to travel. Please continue to observe the work plan modifications as detailed in our November 8, 2012 letter (Technical Comments 1b to 1f) and TC 3. In particular (but not limited to!) the collection of shallow soil in the 0 to 5 and the 5 to 10 foot zones can be very important under the LTCP. Please also upload reports, bore logs, EDFs, GEO WELLs, and etc. to Geotracker. The data is currently lacking and is required by the state to remain in compliance.

Finally, please include site vicinity utility locations on future site maps, including utility depths. If you feel the maps become to busy, then feel free to keep the locations on a utility location map, but include the map as an ongoing figure in future reports.
