Thank you for your email and phone call. As I mentioned in my voice mail, the concern at this site is the lack of a response to our most recent letter (DIR_L_2014-09-15 on Geotracker and on the ACEH website – see the link below my name), in conjunction with the additional indoor air vapor samples from two properties downgradient of the subject site that suggest a potential vapor intrusion concern. Previously, the case had been seeing steady progress, and it has been important to define the downgradient extent of the contamination at the site and vicinity. The "Notice to Comply" letter that was sent is a standard letter requesting actions a the site, as these continued site investigatory actions are what is used to determine compliance. If actions are forthcoming in a reasonable time frame, then no penalties are involved. As such ACEH regards the issues associated with this case to be a data driven rather than legal driven.

If you have the email address for Mr. Merkle, ACEH has found it best to communicate directly with him with communications, including directive letters. We have previously sought his email address, but have not received it.
