Alameda County Department of Environmental Health (ACDEH) has received the attached work plan to conduct work at your property. ACDEH understands that the planned work is for due diligence associated with a potential purchase of the property, with a short timeline. The work plan was requested to be submitted to ACDEH as ACDEH does not allow work on a regulated site, without understanding the intent, adequacy, and appropriateness of the work.

ACDEH has conducted a cursory review of the work plan in order to determine if there is a potential for cross contamination, and that it has been suitably addressed with appropriate Standard Operating Procedures (SOPs), including applying for soil bore permits. The attached SOPs are appropriate for the intended general scope of work.

ACDEH has not conducted an in depth review of the proposed work with reference to potential case closure under the Low Threat Closure Policy (LTCP) or that the work plan addresses all LTCP data gaps identified by ACDEH in previous directive letters or in meetings with you. This can be done; however, will require a minimum of 30 days in order for ACDEH to place it in our normal review lineup.

At this time, ACDEH has no objections to the work proceeding, and will approve soil bore permits once notified by the Alameda County Public Works Agency.

While we have communicated in regards to remaining data gaps at the site, ACDEH has not received an actual work plan with an exact proposed scope of work or standard operating procedures. Without a work plan, ACDEH will not be able to approve boring permits when notified by Public Works that they have been sought. Because the site is a regulated property, no work can commence without ACDEH approval.

If you would like to discuss this further, please let me know. I will need to include Dilan Roe to potentially find a method around this requirement. I do understand that you have a somewhat limited window for due diligence.
