Per my voicemail message on October 9, 2018, Weiss Associates will submit the Site Investigation (and Site Conceptual Model) Report requested in ACDEH's letter dated August 31, 2018 by October 31, 2018. This email confirms our telephone conversation that the ACDEH finds this extension of this submittal deadline acceptable.

We also respectfully request an extension to the December 7, 2018 deadline for the submittal of Interim Remediation Results requested by the same ACDEH letter. We are currently obtaining permits and retaining subcontractors for the work, and the extraction well installations are scheduled for the week of November 5-9, 2018. We request a revised submittal date of February 1, 2019.
