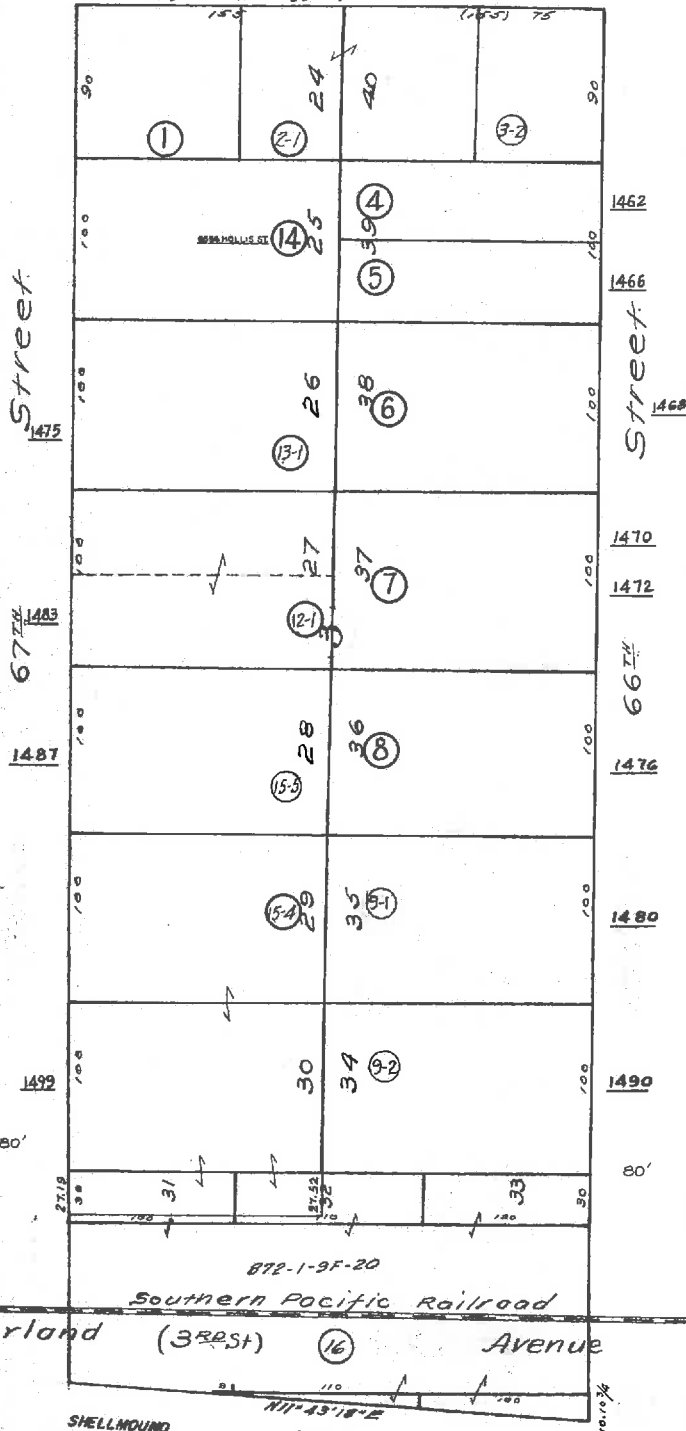
ASSESSOR'S MAP 49 Map of the Maxwell Tract (bk. 5 Pg. 21)
