Dilan:

After contemplating these schedules on and off for the last couple of days it seems there are too many unknowns at this point to make them very meaningful. That said, attached are some fairly rudimentary schedules (separate tabs) for:

RO014 - need to conduct Mobile DPE to establish path forward

RO066

RO076 – need to conduct sub slab soil vapor sampling to establish path forward

RO0426 – need to conduct SPH bail down tests to attempt to evaluate where SPH is coming from and how to deal with it

The biggest challenge is going to be getting into the field to conduct soil vapor/DPE work prior to the rainy season (if possible). Once we get in the field and collect the data I can resubmit schedules that are more accurate. At that time I'll include what needs to get done in order to meet the LTC criteria (CSMs, soil vapor investigations, etc). I have looked at the ACEH website and found most sites do not have a stand alone "CSM". However I have not had time to review all historical documents to see if components of an SCM are available.
