This well MW-1 has a State well Number as 1S/4W16P1. I didn't see or find a WCR number for this well. We don't consider wells destroyed unless they have been destroyed by a permit with County destruction standards. We can consider this well "Lost" but not destroyed. The records will show a well was constructed at this site, but not destroyed. The records will forever be listed as such, until the well has been found and destroyed.

Hello James,

The Alameda County Environmental Health (case manager: Mark Detterman) has requested the destruction of a shallow groundwater monitoring well (MW-1) located at 3310 Powell Street, Emeryville, CA. The well was originally installed on April 8, 1993 by Environmental Science & Engineering Inc. (ESE) for environmental monitoring of former underground fuel storage tanks (USTs) at the site. The well is 2-inch Sch 40 PVC installed to 18.5 ft below grade. The original well installation log is attached to this email.

On June 23, 2015, we went to the site to locate the well, but discovered that the well has been paved over with concrete as part of a parking pay station construction. Please see the attached photos we took on that day. As one of the photos shown, we dug into and beneath the concrete slab in an attempt to locate the well box and the well casing, but did not find any. It is likely that the well box and the top portion of the well casing were removed at the time of the concrete slab construction.

At this juncture, we face extreme difficulty to locate the well as the metal well box has been removed and the top portion of the 2-inch diameter PVC casing has also likely been removed. Since the well is now covered by a concrete slab, we would like to know if you could consider the well is destroyed. The County Environmental Health Department will close this case if you consider the well is destroyed.
