Clayton Group Services (Clayton) has prepared the following progress report for remedial activities completed between April 30, 2004 and September 30, 2004 at the subject property. This work has been performed in general accordance with the scope of work presented in the Engineering Evaluation and Cost Analysis (EE/CA) prepared by Clayton.

As discussed previously in the progress reports, the major components of the remedial activities were completed between October and December 2003. These activities included excavation and disposal of 22,361 tons of material, which included 765 tons of Class I disposal and 21,596 tons of Class II disposal.

Following excavation, the groundwater extraction system continued to operate until June 10, 2004. In accordance with the NPDES permit for the site, the final report for the Dewatering Treatment System was submitted to the Regional Water Quality Control Board (RWQCB) on July 1, 2004. The total volume of groundwater extracted and treated was approximately 2,935,900 gallons.

During this progress report period Clayton performed two quarterly groundwatermonitoring events and prepared the following reports as directed by Alameda County Health Care Services Agency (ACHCSA):
