On behalf of Greyhound Lines, Inc., Engineering-Science, Inc. (ES) is pleased to submit the June, 1992, monthly monitoring report for the Greyhound Terminal in Oakland. Attached you will find Table 1 which lists the depth to liquid, depth to water, and free-product thickness from on-site wells monitored during our site visit. Figure 1 shows the locations of the monitoring wells.

During our site visit on June 16, 1992, free-phase petroleum hydrocarbons were measured in four of the on-site wells. Greyhound is currently in the process of implementing an automated recovery system to recover free-phase hydrocarbons and create groundwater depression toward the wells. Greyhound will keep the Alameda County Department of Health informed of the progress of remediation activities.

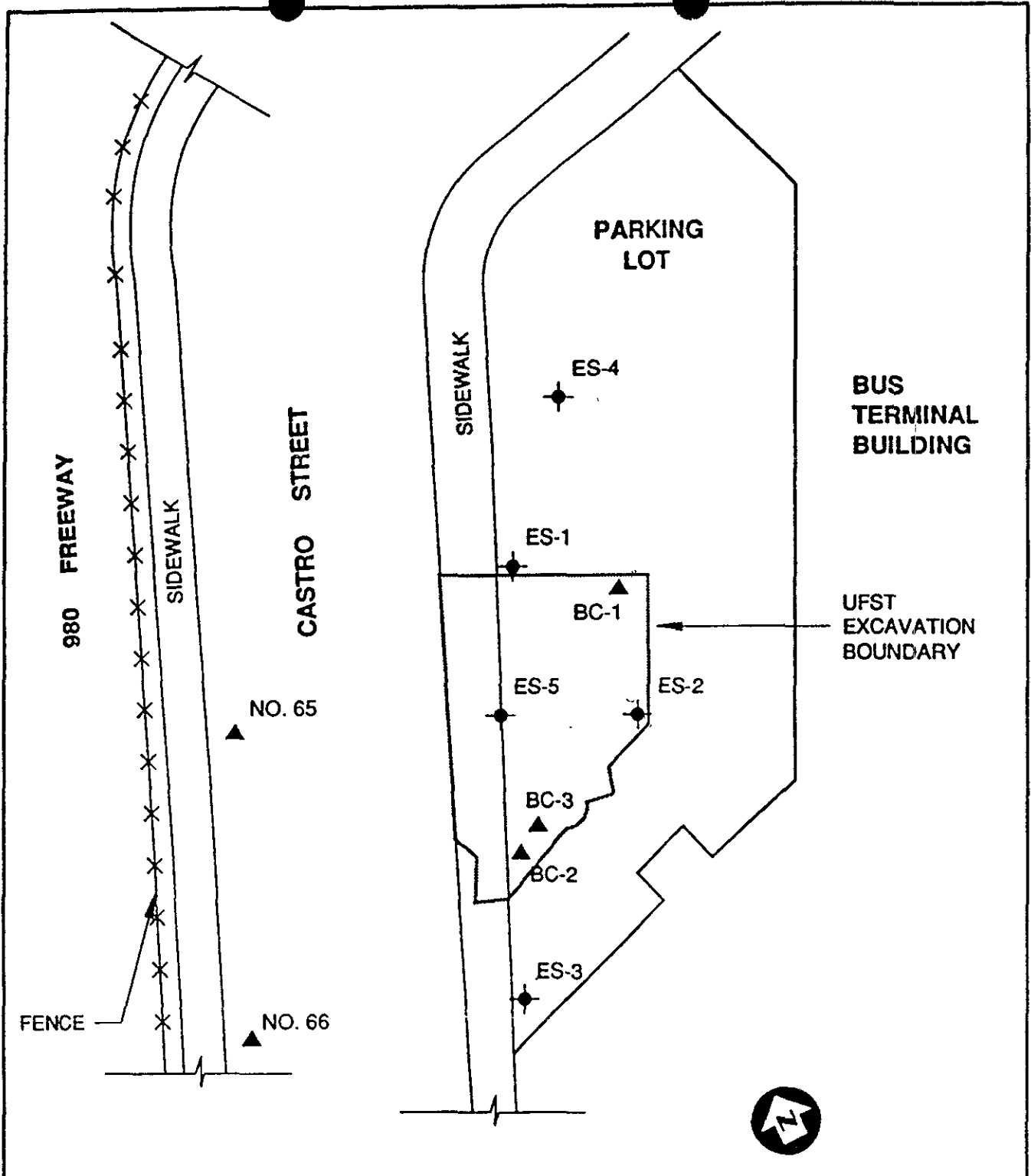
