Dilan:

I'm following up with inquires to sites where I'd like to move forward with remediation and investigation but am waiting for your approval. Can you give me an update on the following:

1. Former BP 11126 (RO0066) – Emeryville, we have an approved CAP, which was supposed to be implemented in March 2012 but I am waiting for ACEH to approve the 30 day public notification.

2. Former BP4931 (RO0076) – Oakland, we submitted an addendum to the soil vapor WP in May 2012 and are awaiting approval.
3. Former BP 11132 (RO004) – Oakland, waiting approval to conduct a mobile DPE (we would like to do this in September if possible).
