As you know we got access and sampled the partial basement on October 25, 2017. We would have sampled earlier however obtaining access delayed the sampling. I was going to consider this the dry season sample as there was very little precipitation prior to sampling (0.11 inches on 10/19 and 0.02 inches on 10/20). Please let me know if you agree with that assessment and we'll plan for our wet season next year.
