Good afternoon Mr. Detterman,

On behalf of 1001 42<sup>nd</sup> Street, LLC, AMEC Geomatrix is currently scheduled to locate monitoring well MW-B1 and implement the Pilot Study by installing extraction well EW-1 and vapor monitoring points VP-1 through VP-3 on the subject property beginning April 14, 2011. In addition, on-site groundwater monitoring wells (BES-1 and MW-B1 through MW-B4) and off-site wells (CW-1 through CW-3) will be gauged and redeveloped on April 15, and samples will be collected on April 18, 2011. The Pilot Study will continue until the first week of May. Due to the time needed to document, tabulate, and prepare the requested technical reports, we would like to respectfully request an extension for the submittal of the Groundwater Monitoring and Sampling Report to June 3, 2011, and for the submittal of the Report of Pilot Study to June 17, 2011.
