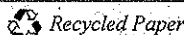
Any underground storage tank (UST) owner, operator, or other responsible party may petition the State Water Resources Control Board (State Water Board) for review of a decision denying case closure. (Health and Safety Code § 25296.40, subd. (a)(1).) The State Water Board has received a petition for case closure review at the above-referenced UST release site.

The State Water Board's UST Program Cleanup Unit is currently reviewing this petition. To understand the nature of the release, history of actions taken at the site and present site conditions, the State Water Board will review the complete agency record for the site and any response to the enclosed petition.

In accordance with section 2814.7 of Chapter 18 of Title 23 of the California Code of Regulations, your agency is required to comply with the following:

1. The State Water Board must receive from you a list of any persons known by your agency to have an interest in the subject matter of the petition within 10 days of the date of this letter.
2. The State Water Board must receive a copy of the complete record relative to the case within 20 days of the date of this letter. The record includes but is not limited to all reports, correspondence, field notes, permits, notices and any other record pertaining to the UST case.



3. The State Water Board must receive a copy of any agency response to the petition within 20 days of the date of this letter. Any agency response must also be provided to petitioner. The deadlines for filing a response to the petition or submitting the record may be extended by the State Water Board.
