As discussed in our telephone conversation today, CRA has twice attempted to obtain an access agreement from the property owner of 1172 Ocean Avenue. In both cases, the property owner returned our letter denying access and did not leave any contact information for follow-up discussion. Also, something I forgot to mention over the phone, after visiting the site and having a driller assess the proposed locations, it became evident that the two proposed two-inch-diameter monitoring wells in the interior of the 1167 65th Street building will not be accessible by a conventional limited-access track-mounted. A smaller track-mounted rig will be

able to fit through the entryway, but can only spin 4-inch-diameter augers and therefore can only install one-inch diameter wells. Is this change to the scope acceptable? The other two monitoring wells would be installed as planned.
