### **Responsible Party Identification Background**

Alameda County Environmental Health (ACEH) names a "Responsible Party," as defined under 23 C.C.R Sec. 2720. Section 2720 defines a responsible party 4 ways. An RP can be:

- 1. "Any person who owns or operates an underground storage tank used for the storage of any hazardous substance."
- 2. "In the case of any underground storage tank no longer in use, any person who owned or operated the underground storage tank immediately before the discontinuation of its use."
- 3. "Any owner of property where an unauthorized release of a hazardous substance from an underground storage tank has occurred."
- 4. "Any person who had or has control over an underground storage tank at the time of or following an unauthorized release of a hazardous substance."

ACEH has named the responsible parties for this site as detailed below.

### **Responsible Party Identification**

#### Existence of Unauthorized Release

Three gasoline underground storage tanks (USTs) located in the southern portion of the facility were reportedly removed circa 1982 to 1983. No reports are available to document the UST removal. The detection of fuel hydrocarbons in soil and groundwater samples collected in the area of the three former USTs confirms that a release occurred from the USTs. Four additional USTs were removed from four separate areas of the site between August 1991 and June 1992. During the USTs removals, fuel hydrocarbons were observed in soils in the immediate area of the USTs. Soil sampling and analysis during the tank removal and during subsequent site investigations confirmed that a release had occurred from the four UST systems. Based on these facts, unauthorized releases occurred from five UST systems located in separate areas of the site.

#### Responsible Party Identification

In a Notice of Requirement to Reimburse dated May 28, 1992, American Brass & Iron Foundry was identified a responsible party for releases from USTs at 7825 San Leandro Street in Oakland, Ca. American Brass & Iron Foundry was named a responsible party for the fuel leaks because they were the business owner, tank owner, and tank operator at the time of the unauthorized releases (Definition 1), owned property where an unauthorized release occurred (Definition 3), and had control of the USTs at the time of or following an unauthorized release (Definition 4). The corporate successor to American Brass & Iron Foundry is McWane, Inc.

In 2006, Nine Plus LLC purchased the four property parcels on which unauthorized releases occurred. Nine Plus LLC is a responsible party because they previously owned the property where unauthorized releases occurred (Definition 3).

McWane, Inc. purchased the four parcels on which unauthorized releases occurred between March 2009 and December 2010. McWane, Inc. is a responsible party because they currently own the property where unauthorized releases occurred (Definition 3).
