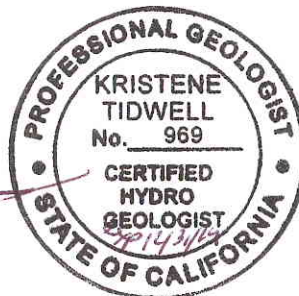

Broadbent & Associates, Inc. (Broadbent) is pleased to present this *First Quarter 2014 Status Report* on behalf of Atlantic Richfield Company (a BP affiliated company) for ARCO Station No. 2035 located on 1001 San Pablo Avenue in Albany, Alameda County, California (the Site). Quarterly reporting is being submitted to the Alameda County Environmental Health Services Agency (ACEH) consistent with their requirements under the legal authority of the California Regional Water Quality Control Board as codified by California Code of Regulations Title 23, Section 2652(d). **WORK PERFORMED THIS QUARTER (First Quarter 2014):**

1. Submitted *Fourth Quarter 2013 Monitoring Report* on January 24, 2014.
2. Carried out preparatory activities for well destructions for Site Closure.
3. Carried out well destruction activities.
4. No environmental field work was conducted at Station No. 2035 during the Third Quarter 2013.

**WORK SCHEDULED FOR NEXT QUARTER (Second Quarter 2014):**

1. Prepare and submit *First Quarter 2014 Status Report* (contained herein).
2. Complete well decommissioning activities.
3. Following completion of well decommissioning activities, prepare a Well Destruction Report.
4. No other environmental activities are scheduled to be carried out during the second quarter 2014.

**DISCUSSION:**

The most recent groundwater monitoring and sampling event occurred during the Second Quarter 2013. The results of this sampling are outlined in the Second Quarter Groundwater Monitoring Report submitted July 29, 2013. Sampling has currently been suspended at the Site pending final case closure. A final closure letter was received on January 29, 2014. Currently, site closure activities including well decommissioning are underway. All environmental activities will likely be completed during the second quarter 2014. A Site Location Map is included as Drawing 1.

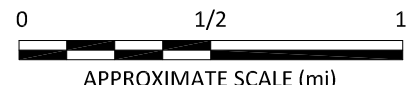
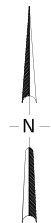
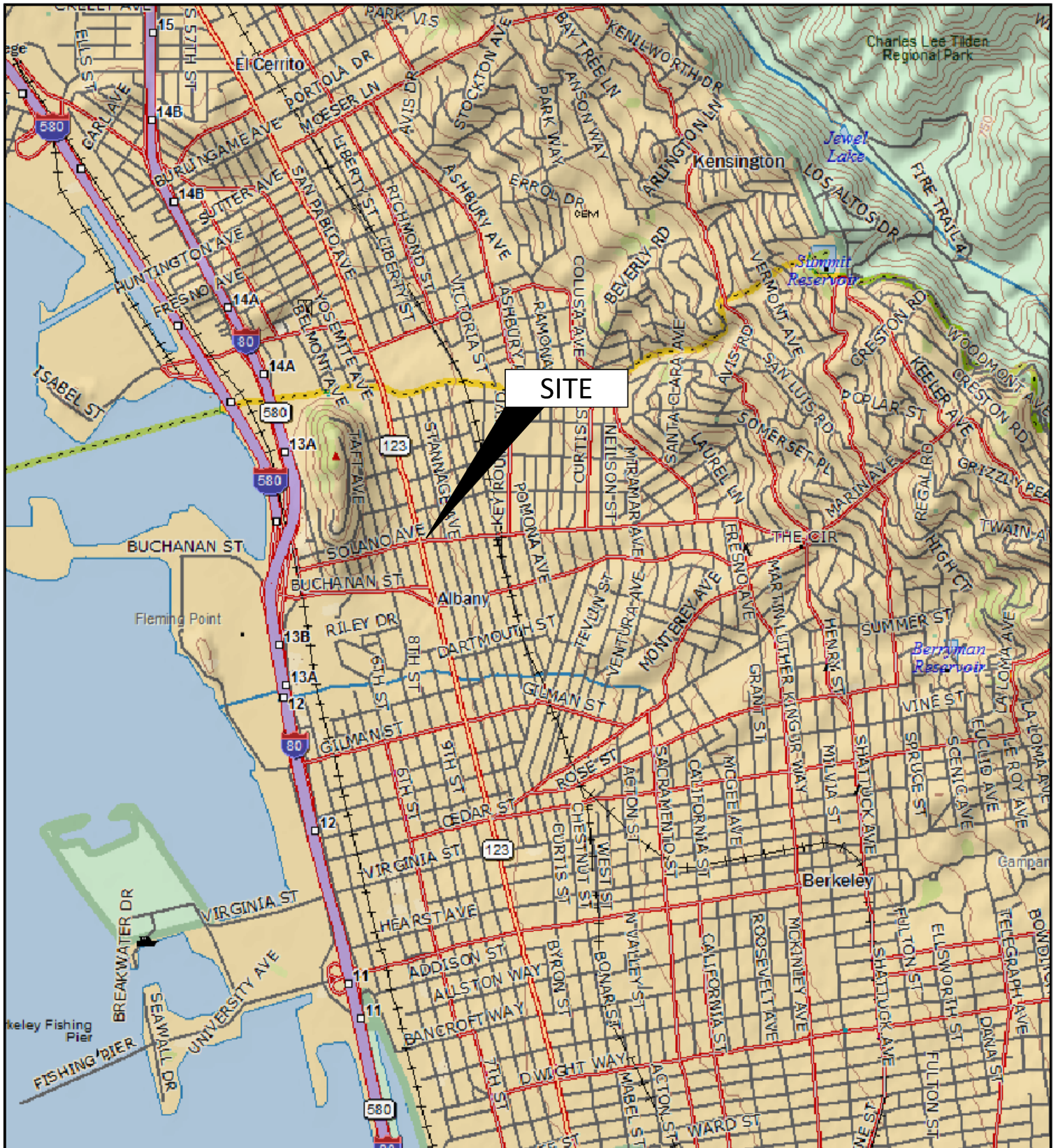
