Hi Bill,

I can provide some limited oversight on a very temporary basis, as in reality this case is now overseen by the RWQCB and I don't want to "speak" for them in a significant way. This would mainly be as a transition contact. The big question is how fast the RWQCB case worker will be able to get up to speed on the site and be able to provide meaningful oversight, and how fast you want to start generating the cross sections so that they are ready for RWQCB use. I / we agree they would be useful; they are an outstanding request from the February 2009 directive letter, and while there is momentum at the site it would be good to keep it going rather than to have it languish in a transition period. If you would like general concurrence that the proposed cross section traces would be appropriate so that you can start generating the cross sections for RWQCB use, I'm willing to assist. Conversely you may want to touch basis with Chuck Headlee to get a determination on how fast they are likely to proceed. Additionally, as a PG you may judge that you can make and support the reason for the selection of cross section lines yourself.

Hope this helps, but do let me know how you'd like to proceed.

Mark Detterman:

I have prepared this e-mail to summarize the scope of our telephone conversations that we had on 03/27/12 and 03/29/12 related to Fuel-Release Case #RO0000107; Di Salvo Trucking, 4919 Tidewater Avenue, Oakland.

WellTest (and the RP) would like to obtain your comments related to any existing deadlines and the submittal procedures of technical data, including geologic cross-sections and other work product (monitoring reports) that we are seeking to submit over the next 90-days prior to the start of the USTCFs July 1, 2012 to June 30, 2013 FY cycle.

03/27/12 Telephone Conversation

During our telephone conversation on 03/27/12 we discussed the need to establish a set of scaled geologic cross sections for the site that will form the basis for an initial site conceptual geologic model (SCGM) for the case. The

sections will tie together the available site lithology, soil and groundwater chemistry data, water level data, well screen intervals (relative to smear-zone soils), the former USTs, and the UST excavation, the groundwater extraction trench (gallery), site buildings, property lines, and the Bay. I noted that the SCGM will also assist in the formulation of an initial site conceptual exposure model (SCEM) of the various pathways associated with the release.

I noted the first proactive step would be the production of a site map showing the surface traces of the proposed cross sections (trace map). We would get the trace map to you in early April 2012, and once approved we would then commit to a timeline to complete the sections. This work product (cross sections) would then serve as a framework to identify appropriate work that should be accomplished through July 1, 2012, and will assist in the formulation of a meaningful budget request for FY 2012-2013 (July 1, 2012 to June 30, 2013) with the USTCF for the case.

03/29/12 Telephone Conversation

On 03/29/12 I noted a copy of a 03/28/12 regulatory letter you wrote and posted on the GeoTracker page for the case. The letter noted the case was to be transferred to the RWQCB. I called you to discuss the contents of the letter, and how this relates to our phone conversation held on 03/27/12.

You confirmed that the case is in flux, but is in the process of being transferred to the RWQCB, likely to be managed by Chuck Headlee. You noted that the pace of corrective action work was expected to be monitored by the RWQCB staff after a transition period of a few months once they formally take on the case, and that the proposed cross sections, and preliminary SCGM and SCEM work that we discussed on 03/27/12 should help change the trajectory of the case in a positive way.

We are seeking your comments related to the proposed timeline for the trace map and geologic cross sections.
