Dear Mr. Sappal:

Alameda County Environmental Health (ACEH) staff has reviewed the case file for the abovereferenced site including the recently submitted document entitled, "Feasibility Study/Corrective Action Plan," (FS/CAP) dated June 29, 2009, which was prepared by AEI Consultants for the subject site. AEI proposes pilot testing bio-venting and in-situ ozone chemical oxidation using the existing wells and conveyance piping from the former SVE system installed at the site. Although fugitive vapor concerns are addressed by the installation of soil vapor monitoring points, ACEH is not convinced that the above-mentioned remedial approach will be sufficient to remediate the off-site groundwater contaminant plume. Since at this stage, only pilot testing is proposed, ACEH is not opposed to the proposed scope of work. However, sufficient detail was not presented in the above-mentioned FS/CAP for approval. Therefore, ACEH requests that you address the following technical comments and send us the FS/CAP Addendum requested below.

TECHNICAL COMMENTS

- 1. Soil Vapor Monitoring Probes AEI states that they will "...install soil vapor monitoring probes to collect pressure readings. The soil vapor probes will be installed at distances of approximately 5, 10, 15, and 20 feet from select injection wells to monitoring radius of influence data." However, it is not clear which well have been selected as injection wells and the locations of the proposed soil vapor probes are unknown. Please clarify which wells are selected as injection wells and discuss applicability as remediation wells (i.e. discuss the well construction details in relation to the target clean up zone). Also please include a revised site figure that identifies the proposed injection wells and locations of the soil vapor probes. Please submit a FS/CAP Addendum due by the date specified below.
- 2. <u>Site Remediation</u> As mentioned above, AEI has proposed bio-venting and in-situ ozone chemical oxidation to remediate the soil and groundwater at the subject site. Although this approach may remediate soil and groundwater contamination on-site, ACEH is concerned that it may not be readily implementable off-site on adjacent properties and streets. Another concern is also the potential for vapor migration along subsurface utility corridors or other subsurface preferential pathways as a result of ozone injection, which may adversely affect off-site properties. Please address the above-mentioned concerns and submit an FS/CAP Addendum due by the date specified below.

3. <u>Groundwater Contaminant Plume Monitoring</u> – Quarterly groundwater sampling has been conducted for the most part since November 1999. At this time, a monitoring frequency reduction appears warranted. Please initiate semi-annual groundwater sampling conducted in the first and third quarters of the year. Should you have an alternate proposal, please submit a groundwater monitoring plan for review. This may include a combination of quarterly, semi-annually, or annually sampled groundwater monitoring wells. Please include the proposal in the FS/CAP Addendum due by the date specified below. In the interim, as stated above, please initiate semi-annual groundwater sampling at the site.

NOTIFICATION OF FIELDWORK ACTIVITIES

Please schedule and complete the fieldwork activities by the date specified below and provide ACEH with at least three (3) business days notification prior to conducting the fieldwork, including routine groundwater sampling.

TECHNICAL REPORT REQUEST

Please submit technical reports to ACEH (Attention: Paresh Khatri), according to the following schedule:

- Monday, October 12, 2009 FS/CAP Addendum
- **Due within 30 Days of Sampling** Semi-annual Monitoring Report (3rd Quarter 2009)
- **Due within 30 Days of Sampling** Semi-annual Monitoring Report (1st Quarter 2010)

These reports are being requested pursuant to California Health and Safety Code Section 25296.10. 23 CCR Sections 2652 through 2654, and 2721 through 2728 outline the responsibilities of a responsible party in response to an unauthorized release from a petroleum UST system, and require your compliance with this request.

ELECTRONIC SUBMITTAL OF REPORTS

ACEH's Environmental Cleanup Oversight Programs (LOP and SLIC) require submission of reports in electronic form. The electronic copy replaces paper copies and is expected to be used for all public information requests, regulatory review, and compliance/enforcement activities. Instructions for submission of electronic documents to the Alameda County Environmental Cleanup Oversight Program FTP site are provided on the attached "Electronic Report Upload Instructions." Submission of reports to the Alameda County FTP site is an addition to existing requirements for electronic submittal of information to the State Water Resources Control Board (SWRCB) GeoTracker website. In September 2004, the SWRCB adopted regulations that require electronic submittal of information for all groundwater cleanup programs. For several years, responsible parties for cleanup of leaks from underground storage tanks (USTs) have been required to submit groundwater analytical data, surveyed locations of monitoring wells, and <u>other</u> data to the GeoTracker database over the Internet. Beginning July 1, 2005, these same reporting requirements were added to Spills, Leaks, Investigations, and Cleanup (SLIC) sites. Beginning July 1, 2005, electronic submittal of a complete copy of all reports for all sites is

required in GeoTracker (in PDF format). Please visit the SWRCB website for more information on these requirements (<u>http://www.swrcb.ca.gov/ust/electronic_submittal/report_rqmts.shtml</u>. <u>PERJURY STATEMENT</u>

All work plans, technical reports, or technical documents submitted to ACEH must be accompanied by a cover letter from the responsible party that states, at a minimum, the following: "I declare, under penalty of perjury, that the information and/or recommendations contained in the attached document or report is true and correct to the best of my knowledge." This letter must be signed by an officer or legally authorized representative of your company. Please include a cover letter satisfying these requirements with all future reports and technical documents submitted for this fuel leak case.

PROFESSIONAL CERTIFICATION & CONCLUSIONS/RECOMMENDATIONS

The California Business and Professions Code (Sections 6735, 6835, and 7835.1) requires that work plans and technical or implementation reports containing geologic or engineering evaluations and/or judgments be performed under the direction of an appropriately registered or certified professional. For your submittal to be considered a valid technical report, you are to present site specific data, data interpretations, and recommendations prepared by an appropriately licensed professional and include the professional registration stamp, signature, and statement of professional certification. Please ensure all that all technical reports submitted for this fuel leak case meet this requirement.

UNDERGROUND STORAGE TANK CLEANUP FUND

Please note that delays in investigation, later reports, or enforcement actions may result in your becoming ineligible to receive grant money from the state's Underground Storage Tank Cleanup Fund (Senate Bill 2004) to reimburse you for the cost of cleanup.

AGENCY OVERSIGHT

If it appears as though significant delays are occurring or reports are not submitted as requested, we will consider referring your case to the Regional Board or other appropriate agency, including the County District Attorney, for possible enforcement actions. California Health and Safety Code, Section 25299.76 authorizes enforcement including administrative action or monetary penalties of up to \$10,000 per day for each day of violation.

The Alameda County Environmental Cleanup Oversight Programs (LOP and SLIC) require submission of all reports in electronic form to the county's ftp site. Paper copies of reports will no longer be accepted. The electronic copy replaces the paper copy and will be used for all public information requests, regulatory review, and compliance/enforcement activities.

REQUIREMENTS

- Entire report including cover letter must be submitted to the ftp site as a single portable document format (PDF) with no password protection. (Please do not submit reports as attachments to electronic mail.)
- It is **preferable** that reports be converted to PDF format from their original format, (e.g., Microsoft Word) rather than scanned.
- Signature pages and perjury statements **must** be included and have either original or electronic signature.
- Do not password protect the document. Once indexed and inserted into the correct electronic case file, the document will be secured in compliance with the County's current security standards and a password.
 Documents with password protection will not be accepted.
- Each page in the PDF document should be rotated in the direction that will make it easiest to read on a computer monitor.
- Reports must be named and saved using the following naming convention:
 - RO#_Report Name_Year-Month-Date (e.g., RO#5555_WorkPlan_2005-06-14)

Additional Recommendations

• A separate copy of the tables in the document should be submitted by e-mail to your Caseworker in **Excel** format. These are for use by assigned Caseworker only.

Submission Instructions

- 1) Obtain User Name and Password:
 - a) Contact the Alameda County Environmental Health Department to obtain a User Name and Password to upload files to the ftp site.
