Dear Mr. Khatri:

All Environmental Inc. (AEI) has prepared this time extension request on behalf of Mr. Pritpaul Sappal (client) in response to the Alameda County Health Care Services Agency (ACHCSA) letter date January 27, 2009. Per our recent phone conversation, in an effort to address known contamination in a timely manner, AEI requests that the additional offsite monitoring wells necessary at the site be put on hold while site mitigation alternatives are evaluated. AEI understands that these wells are required in the future, but at this time is working to evaluate potential remedial options to address both the known adsorbed and dissolved hydrocarbon contamination.

As outlined in the ACHCSA letter, the brief work plan and subsequent soil and water investigation report were due on March 30, 2009 and April 28, 2009, respectively. AEI plans to include the requested brief work plan in the Feasibility Study/Corrective Action Plan (FS/CAP) currently due on June 29, 2009. Following the submission of the FS/CAP, a modified schedule for the completion of the offsite wells will be proposed.

In summary, each of the requested technical reports in the January 27, 2009 ACHCSA letter are expected to be submitted by the respective original due date with the following proposed changes:

- The brief work plan for additional vertical delineation previously due on March 30, 2009 will be included in the FS/CAP due on June 29, 2009.
- A due date for the submission of the soil and water investigation report (detailing the proposed offsite wells) previously due on April 28, 2009 is not proposed at this time. Following the submission of the FS/CAP, a modified schedule for the completion of the offsite wells will be proposed.
