We hereby submit specifications and estimates for the following:

Task 1 - Workplan and Site Safety Plan Preparation

- Prepare a workplan to be submitted to the Alameda County Department of Environmental Health (ACDEH) and the Regional Water Quality Control Board - San Francisco Bay Region (RWQCB)
- Prepare a Site Safety Plan
- Obtain necessary permits and licenses (drilling, business, etc.)

Task 2- Perform Subsurface Environmental Investigation

- Notify Underground Service Alert for utility markings.
- Schedule work time with regulatory agency
- Advance up to eight (8) soil borings on the property around the former underground storage tank areas.
- Collect soil samples at 5-foot intervals, or intervals determined in the field, from each soil boring.
- Screen each soil sample visually and with an OVM to determine potential hydrocarbon contamination.
- Collect water samples from each boring if encountered within 25 feet below ground surface.
- Analyze up to 8 soil and 8 groundwater samples at a state certified laboratory for TPH-G,
 TPH-D, and BTEX. Additional analysis may be required by regulatory agency.
- Backfill all borings with neat cement slurry to surface grade

- Prepare a graphic geologic log of the lithology of each boring
- Prepare a site map showing the locations of all borings.

Task III - Report Preparation

- Prepare a report of the field method, findings, and conclusions. Submit report to the ACDEH.
- Site investigation preparation by registered professional engineer.

During this project, we recommend that the Owner or representative be on site or available by telephone.


