Dilan and I wanted to send you a quick email to let you know that I've realized there is another site that we did not discuss at the March 13<sup>th</sup> meeting. A site investigation report was due to be submitted on March 3, and thus is overdue. This is a site that Brian has had conversations with the SWRCB and site work appears to have been delayed as a result. The work was an attempt to fill the data gaps in an effort to determine if the site could be closed under the LTCP. Consequently, it appears that a NTC is needed.
