Hi James,

I don't see that the data will add significant information to either site, consequently I believe that both sites can be reduced from a semi-annual to an annual sampling interval. Both sites look like "worst case" concentrations may generally be obtained during the regularly scheduled August sampling event. That means sampling all wells for RO368 in August, a reasonable change. I may ultimately either agree or disagree with the closure request, but in the interim the additional data will not figure prominently in that decision. Please use this email as approval to hold the sampling scheduled for next week.

For these two sites, we have sampling scheduled for 2/8, so I was curious if suspending GWM until the documents can be reviewed was a possibility. If you could let me know I'd appreciate it. Thanks.
