Dear Ladies and Gentlemen:

Alameda County Department of Environmental Health Department (ACDEH) staff has reviewed the case file, including the document entitled *Fuel Leak Case No, RO0000138*, dated June 10, 2016, and the *Off-Site Vapor Intrusion Assessment Report*, dated September 27, 2016. The letter was prepared by Chevron Environmental Management Company, and the report was prepared and submitted on your behalf by Stantec Consulting Services Inc. (Stantec). Thank you for submitting the report.

The report documents the sampling of offsite crawl space and outdoor air in an effort to determine the risk of vapor intrusion at a downgradient offsite commercial property. This was a change in the original scope of work proposed for offsite areas in the *Site Conceptual Model and Data Gap Work Plan,* dated March 21, 2014, due to a number of impediments in implementing the plan. Impediments included public and private property soil bore location restrictions, permitting delays, offsite private property access issues, and soil recovery problems, among other impediments. Based on a one time sampling event, the referenced report documents a somewhat elevated crawl space vapor concentration of naphthalene in the crawl space vapor sample above vapor concentrations in the outdoor air background vapor sample. The crawl space concentration is above the Regional Water Quality Control Boards (RWQCBs) Environmental Screening Level (ESL) for indoor air. The outdoor air sample is not.

Implementation other aspects of the originally proposed scope of work to assess the onsite risk of vapor intrusion from the former service station was also delayed due to other site access problems which appear to have resolved themselves in the intervening period of time with a change in tenants at the subject site. This aspect of the site was detailed in the referenced document entitled *Fuel Leak Case No, RO0000138*.

Therefore, ACDEH requests that you address the following technical comments, perform the proposed work, and send us the reports described below. Please provide 72-hour advance written notification to this office (e-mail preferred to: <u>mark.detterman@acgov.org</u>) prior to the start of field activities.

TECHNICAL COMMENTS

- 1. Onsite Investigation Impediments In the normal course of a contaminant investigation, ACDEH does not get involved in the decision of which named Responsible Party conducts an investigation; each is jointly and severally liable for the costs of investigations, and if necessary, the cleanup of that contamination. This is a matter properly left for discussion among named Responsible Parties. Please be aware that each of the parties listed at the top of this letter are identified and named as Responsible Parties using State of California required protocols. Please be aware that continued onsite investigation impediments may require ACDEH to assign the responsibility and associated costs for the onsite investigation to the current property owners due to their unique relationship with their tenants.
- 2. Previously Addressed Soil Vapor Data Collection Clarifications Please be aware that all unaddressed areas of the previous directive letter remain of concern to ACDEH, and it is important to resume previously proposed work as conditionally modified in the previous directive letter. Please see a copy of that letter, dated May 6, 2014, for details, which include modifications to the onsite vapor investigation, a well survey, and a sensitive receptor survey.
- 3. Offsite Vapor Investigation Based on ACDEH's review of the referenced report, it appears appropriate to incorporate an additional offsite crawl space sampling event in order to capture temporal differences in vapor concentrations beneath the offsite commercial building. This is requested to be conducted concurrent with onsite work referenced in Technical Comment 1 above, and is requested to utilize previously accepted standard protocols in use at the site.
- 4. Annual Groundwater Monitoring and Sampling Please continue to conduct annual groundwater monitoring at the site and submit a report by the date identified below.

REPORT REQUESTS

These reports are being requested pursuant to California Health and Safety Code Section 25296.10. 23 CCR Sections 2652 through 2654, and 2721 through 2728 outline the responsibilities of a responsible party in response to an unauthorized release from a petroleum UST system, and require your compliance with this request.

ELECTRONIC SUBMITTAL OF REPORTS

ACEH's Environmental Cleanup Oversight Programs (LOP and SLIC) require submission of reports in electronic form. The electronic copy replaces paper copies and is expected to be used for all public information requests, regulatory review, and compliance/enforcement activities. Instructions for submission of electronic documents to the Alameda County Environmental Cleanup Oversight Program FTP site are provided on the attached "Electronic Report Upload Instructions." Submission of reports to the Alameda County FTP site is an addition to existing requirements for electronic submittal of information to the State Water Resources Control Board (SWRCB) GeoTracker website. In September 2004, the SWRCB adopted regulations that require electronic submittal of information for all groundwater cleanup programs. For several years, responsible parties for cleanup of leaks from underground storage tanks (USTs) have been required to submit groundwater analytical data, surveyed locations of monitoring wells, and other data to the GeoTracker database over the Internet. Beginning July 1, 2005, these same reporting requirements were added to Spills, Leaks, Investigations, and Cleanup (SLIC) sites. Beginning July 1, 2005, electronic submittal of a complete copy of all reports for all sites is required in GeoTracker (in PDF format). Please SWRCB visit the website for more information on these requirements (http://www.waterboards.ca.gov/water issues/programs/ust/electronic submittal/).

PERJURY STATEMENT

All work plans, technical reports, or technical documents submitted to ACEH must be accompanied by a cover letter from the responsible party that states, at a minimum, the following: "I declare, under penalty of perjury, that the information and/or recommendations contained in the attached document or report is true and correct to the best of my knowledge." This letter must be signed by an officer or legally authorized representative of your company. Please include a cover letter satisfying these requirements with all future reports and technical documents submitted for this fuel leak case.

PROFESSIONAL CERTIFICATION & CONCLUSIONS/RECOMMENDATIONS

The California Business and Professions Code (Sections 6735, 6835, and 7835.1) requires that work plans and technical or implementation reports containing geologic or engineering evaluations and/or judgments be performed under the direction of an appropriately registered or certified professional. For your submittal to be considered a valid technical report, you are to present site specific data, data interpretations, and recommendations prepared by an appropriately licensed professional and include the professional registration stamp, signature, and statement of professional certification. Please ensure all that all technical reports submitted for this fuel leak case meet this requirement.

UNDERGROUND STORAGE TANK CLEANUP FUND

Please note that delays in investigation, later reports, or enforcement actions may result in your becoming ineligible to receive grant money from the state's Underground Storage Tank Cleanup Fund (Senate Bill 2004) to reimburse you for the cost of cleanup.

AGENCY OVERSIGHT

If it appears as though significant delays are occurring or reports are not submitted as requested, we will consider referring your case to the Regional Board or other appropriate agency, including the County District Attorney, for possible enforcement actions. California Health and Safety Code, Section 25299.76 authorizes enforcement including administrative action or monetary penalties of up to \$10,000 per day for each day of violation.

The Alameda County Environmental Cleanup Oversight Programs (LOP and SLIC) require submission of all reports in electronic form to the county's ftp site. Paper copies of reports will no longer be accepted. The electronic copy replaces the paper copy and will be used for all public information requests, regulatory review, and compliance/enforcement activities.

REQUIREMENTS

- Please <u>do not</u> submit reports as attachments to electronic mail.
- Entire report including cover letter must be submitted to the ftp site as a single portable document format (PDF) with no password protection.
- It is preferable that reports be converted to PDF format from their original format, (e.g., Microsoft Word) rather than scanned.
- Signature pages and perjury statements must be included and have either original or electronic signature.
- <u>Do not</u> password protect the document. Once indexed and inserted into the correct electronic case file, the document will be secured in compliance with the County's current security standards and a password. Documents with password protection <u>will not</u> be accepted.
- Each page in the PDF document should be rotated in the direction that will make it easiest to read on a computer monitor.
- Reports must be named and saved using the following naming convention:

Submission Instructions

- 1) Obtain User Name and Password
