Welcome back from your absence/vacation(?). As I mentioned in my voicemail to you, I am writing to request an URGENT informal MEETING with you THIS WEEK. The responsible party, Gary Feiner, has informed me that he desperately needs your directive letter approving the July 2007 IRAP or he may need to declare BANKRUPTCY within DAYS TO A FEW WEEKS. This would reflect poorly on all parties, and could trigger unknown ramifications. Your agency has had the IRAP for over ten months and Gary urgently needs regulatory oversight attention.

I was hoping I could help walk you through the project history and our documents to help expedite preparation of an agency directive letter. We respectfully request that the directive letter APPROVE the IRAP (with any required conditional items) rather than request additional information prior to IRAP approval.
