This email provides the clarification of proposed soil gas sampling as requested by your August 22, 2012 letter. Please review both soil gas sampling documents. The *Revised Soil Gas Sampling Workplan* dated July 16, 2012 proposes *offsite* subslab soil gas sampling. An *Addendum* to the workplan is dated August 6, 2012 and adds proposed soil gas sampling for *onsite* (5175 Broadway proper). This work scope is also clarified in the Addendum and follows our verbal correspondence.

As we discussed yesterday, you plan to review these plans on Tuesday, August 28, 2012. Due to project time constraints (and prior ACEH commitment to review workplans within about 2-3 weeks), Pangea has already scheduled the soil gas sampling for Thursday, August 30, 2012.
