Alameda County Environmental Health (ACEH) would like to thank all of the interested parties for their participation in the May 6, 2009 meeting at our offices. During the meeting, Chevron and Oakland Housing Authority requested that ACEH concur that onsite remedial action was completed in accordance with the June 28, 2007 Remedial Action Plan (RAP).

Chevron submitted the results from the remedial action in the July 11, 2008 Remediation Activities Report (RAR). ACEH concurs that remediation of contaminated soil completed to date conform to the RAP dated June 28, 2007. ACEH concurs with the recommendation that remnant areas of contamination and debris which remain onsite will be defined and mitigated, under ACEH oversight, during construction in accordance with the RAP. ACEH further concurs with the proposal to decommission the existing vapor wells.
