Dear Mr. Wickham :

Thank you for providing instructions on how to access the various on line material pertaining to the above referenced fuel Leak , as well as providing me with a disc of the file on 12/06/11

A you know, the information that accumulated over six years is extensive, complex and technical. We have identified **92 reports** spread over **4004 pages** that require scrutiny and evaluation by appropriate experts.

Your general circular mentioning your intention to close the case was the first time I was made aware of the existence of this leak adjacent to my property. As such, a determination needs to be made as to whether you have prejudiced me by not giving me prior notice .

While I appreciate your granting a five day extension, please know that it is woefully inadequate for the time needed to properly evaluate the voluminous data involved in the investigation up to the present time as well as the mitigative measures, monitoring


protocols , future reporting methods that are put in place, to prudently address this issue which bears on the health and safety of my family ( as owners who are closely involved with the properties ) as well as all of my tenants (over twenty individuals).

Based on the preliminary appraisal of the data, we are in the process of determining the time needed to carefully analyze the material that has been made available. Once that appraisal is completed I will notify you of the time needed for us to knowledgeably comment on the matter. This case apparently has been pending for some six years. As such, it would seem that to extend the period before closure would make sense given the potential of affecting so many people.

I thus respectfully request that the case be kept open for an additional six(6) months from the date of this letter.
