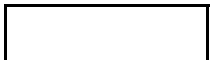
With all the rain predicted for this week we are not sure if we will be able to collect the soil vapor samples at RO167 and the turn-around-time on soil vapor samples is two weeks.

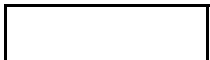
Mark,
