Mark -

This email follows our recent conversation and your letter dated June 3, 2011.

The day after receiving your letter we spoke with Mr. Welsh about ACEH's requirements. The conversation clearly revealed Mr. Welsh to be elderly, in poor health, and of limited financial means. Mr. Welsh asked us to assist him in complying with the ACEH letter.

Unfortunately, Mr. Welsh is not in the UST Fund because he has never applied. We offered to assist him in applying to the Fund, which would then allow us to help Mr. Welsh comply with your requirements regarding the environmental conditions at the Site. Mr. Welsh accepted our offer of assistance. Therefore, we propose to first assist Mr. Welsh in getting accepted by the UST Fund, and once accepted, we would assist Mr. Welsh in addressing the environmental concerns at his property.

In light of this approach and due to the Fund's current questionable status, we request on behalf of the Mr. Welsh, that ACEH revise the schedule to the following:

- October 28 - Work Plan for a Soil and Groundwater Investigation (with preferential pathway Study)
- November 4, 2011 - Documentation of Geotracker and ACEH Website Uploads
- 60 Days After Approval of Work Plan - Report on Soil and Groundwater Investigation.

Please be assured that we will let you know when Mr. Welsh is accepted into the Fund, and we will propose adjustments to the schedule accordingly, which could result in the work being performed sooner than the schedule proposed above. We may also ask you for a letter supporting Mr. Welsh's application to the Fund.

Finally, we plan on meeting with Mr. Welsh next week to get the application to the Fund moving forward. Your positive response to this email would help our discussions with Mr. Welsh.
